# **Privacy Policy**

# 1 GENERAL INFORMATION AND DISCLAIMER

The use of the websites of GestureTek Systems Inc., and GestureTek Health (<a href="www.gesturetek.com">www.gesturetek.com</a>, <a href="www.gesturetek.com">www.gesturetekhealth.com</a> and other sites belonging to the gesturetek.com or gesturetekhealth.com domains) (hereinafter referred to as the "Websites"), offered by GestureTek & GestureTek Health, sister companies duly incorporated pursuant to the laws of Canada, with registered office at 145 Front St. E, Toronto, ON, Canda (hereinafter referred to as "GestureTek & GestureTek Health"), implies in all cases the collection of certain information about its customers and service users.

## 2 CONTROLLERS

### 3 THE PERSONAL DATA SUBJECT TO PROCESSING

### 4 USE OF PERSONAL DATA

GestureTek & GestureTek Health may also use personal data for the following purposes:

# 6 DATA DISCLOSURES, INTERNATIONAL TRANSFERS AND AUTOMATED DECISION-MAKING

GestureTek & GestureTek Health do not disclose data to third parties.

GestureTek & GestureTek Health do not adopt any decisions that could affect you in a significant manner based solely on automated processing of your data. All decision-making processes of our company related to your requests, services, queries or purchases are conducted with the involvement of a human being.

### 7 STORAGE PERIOD

The Web Users' personal data will be kept for as long as their relationship with GestureTek & GestureTek Health continues. After the relationship with the Web User has ended, GestureTek & GestureTek Health will keep the Web User's data for the legal statutes of limitations applicable to each processing, up to a maximum term of five (5) years after the relationship with the Web User has ended. In such case, the data will only be processed to demonstrate that we have fulfilled our legal or contractual obligations. Once such statutes of limitations have ended, their data will be deleted or, alternatively, anonymised.

# 8 SECURITY AND CONFIDENTIALITY MEASURES APPLIED TO THE DATA

GestureTek & GestureTek Health have implemented and maintain administrative, technical and organizational measures appropriate to the kind of data it collects and subject to the terms and conditions set out in the applicable data protection regulations for the purpose of protecting the personal information provided to GestureTek & GestureTek Health against unauthorized or unlawful access and accidental loss, damage, alteration or destruction of data. Only authorized staff may access the personal information and they may only do so for the permitted business purposes. Notwithstanding the foregoing, criminal acts may be committed by third parties even where GestureTek & GestureTek Health uses all the means at its disposal to prevent such acts.

### 9 EXERCISING YOUR RIGHTS
